#### CARBONDALE AREA SCHOOL DISTRICT

### PARENT INVOLVEMENT POLICY

The Carbondale Area School District agrees to implement the following statutory requirements:

- The school district will put into operation programs, activities and procedures for the involvement of parents in all of its schools with Title I, Part A programs, consistent with section 1118 of the Elementary and Secondary Education Act (ESEA). - 1. The Carbondale Area School District will take the following actions to involve parents in the joint development of its district wide parental involvement plan under section 1112 of the ESEA: Parents will review the parent involvement policy at the annual parent meeting.

Participants in this meeting will be parents, the elementary school principal, the federal programs coordinator, and Title I teachers.

- 6. The Carbondale Area School District will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
  - A. The school district will, with the assistance of its Title I, Part A schools, provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph --
    - the State's academic content standards.
    - the State's student academic achievement standards,
    - the State and local academic assessments including alternate assessments,

Parents will have the opportunity to participate in parent conferences and workshops, which may be appropriate in providing them with the understanding of Pennsylvania state standards and local assessments. Parent/Teacher communication can also be utilized as an avenue in understanding how to monitor their child's progress.

B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by: Parents will be

- provided with appropriate literature regarding academic achievement through the Parents Resource Center. Parents will also be encouraged to participate in the educational process through ongoing communications with educators.
- C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by: Educators will be involved in workshops, trainings and in-services which will assist them in understanding the value and the necessity of parental involvement in the educational process.
- D.
