

# Carbondale Area Elementary School Parent Involvement Policy

## GENERAL EXPECTATIONS

Carbondale Area Elementary School agrees to implement the following statutory requirements:

- Carbondale Area Elementary School will jointly develop with parents and distribute to parents a Parental Involvement Policy that the school and parents agree on.

5. Carbondale Area Elementary School will hold a flexible number of meetings at varying times:

*Various activities will be offered to encourage parent involvement.*

Carbondale Area Elementary School will provide information about Title I programs to all parents in a timely manner through the automated phone system, newsletters, and the web page.

Carbondale Area Elementary School will provide all parents with a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet through:

- *the annual Title I parent meeting*
- *regular parent/teacher conferences*

- *through prearranged meetings with the Title I Coordinator*

- (b) Carbondale Area Elementary School will submit to the district any parent comments if the school wide plan under section (1114)(b)(2) is not satisfactory to parents of participating children:

- *Parents may submit comments in writing regarding the school wide plan to their child's teacher, the Title I Coordinator, the principal, or the appropriate department within Travis Unified School District.*

parents, and the community to improve student academic achievement through the following activities described below:

2. The school will incorporate the school-parent compact as a component of its School Parental Involvement Policy:
