- 1. Program Coordinator This position is a 12-month position starting in July of 2017. Interested candidates must have a Bachelor's degree or higher, a minimum of 5 years' experience as an administrator in a School-Based Center Program, Experience in Crisis counseling and adolescent intervention programming.
 - This position will coordinate all programming for students, will be liaison between family and school staff, will conduct staff trainings, and supervise a staff of two teachers, two para professionals.
- 2. Social Worker- This is a 10-month administrative position beginning August 1st 2017. Candidate must possess LCSW with a minimum of 5 years' experience working with students in Center Based Programs. Must have knowledge of ABA programming, and have explicit and relentless focus on outcomes.
- 3. Board Certified Behavioral Analyst This is a 10-month Administrative position beginning August 1st 2017. The behavior specialist will provide expertise in conducting functional behavior assessments, and connecting them to student behavior support plans, and supporting plan implementation. Conduct task analysis of learning and behavioral performance. Position will work side-by-side with our Center-based staff. Candidate must possess extensive experience in Center Based Programming. Master's Degree preferred.
- **4. Special Education Teachers (2 positions available)** Candidate(s) must be PA certified in grades 7-12 and have a minimum of 3 years' experience teaching in a center-based program. Candidate will work with a highly trained staff in delivering evidenced based instruction to students with Autism and behavioral needs.
