UAS: Loaning library of resources for remote learning or supporting students with disabilities in a remote world; different then AT library as it provides an array of resources to districts and IUs to loan out as they need it; intent was for districts to trial resources to support UDL processes and available for quick turnaround; only available to Sig Dis districts currently, new list coming out in January

- Covid Compensatory: What's working and known issues surfacing in due process cases?
- Child Find Peri and Post Pandemic: What should trigger an evaluation?
   Truancy/School avoidance? What about lack of instruction? When does
   Regression from lack of engagement during Covid become a disability and not something to be addressed by MTSS and other programs designed to close Covid gaps for all?
- FAPE Waivers: How are the holding up in due process?
- Covid Language to Use in the IEP
- Areas getting us in trouble in the IEP leading to due process complaints?
- Open Forum
  - Attendance Procedures
    - Reminder that the IU will be sending attendance information to LEA and whomever is identified as the "truancy" contact at the district. Spreadsheet forthcoming to identify those individuals.
  - Attendance due to student not having a nurse
    - Implications for due process
    - Discussion surrounding students not attending school due to not having a nurse.
      - 3 different types: students not attending at all; students only attending specific days; students attending sporadically
      - FAPE is not being provided at what point do we discuss homebound/instruction in the home and/or other options?

- ASL in Communication Plans
  - Student's parent wanting ASL listed as primary mode of communication when the student is not fluent in ASL and communicates mostly with spoken language: consensus of the group is that spoken language would be primary
- Transgender Students how to write legally correct reports, how to score assessments with gender norms, etc.
  - Additional information will be needed; discussed going to direct to vendor of standardized assessments with question about tests with gender norms; cannot upload student data in PIMS that doesn't match PA Secure ID gender and name, but can use student chosen name in all paperwork- thinking without parent consent, but check with solicitor
